h. Helping a. Achieve r. Recovery t. Together	h.a.r.t. is a two-year, four-phase, opioid-specific drug court giving defendants with a history of treatment refusal or non-compliance the opportunity to engage in addiction treatment.
L. Learning to I. Identify & N. Navigate C. Change	LINC Court, formally Mental Health Court, works with defendants dealing with mental illness. Participants spend their time in LINC receiving mental health and substance use treatment while working toward a more stable life.
RC RECOVERY COURT Rise to the Challenge	<u>Effective Treatment as an Alternative to Incarceration-Recovery Court</u> addresses the needs of defendants whose primary dependency on alcohol or non-opiate drugs results in criminal charges and low-level felonies.

Curriculum/Core Rotations

Addiction Consult Team (ACT) (Four, 4-Week Blocks)

Objective: Deliver exceptional patient care while providing a high-quality educational experience in addiction medicine.

Fellows gain hands-on experience with our consult team at Grant Medical Center, managing patients with substance use disorders alongside other medical and surgical conditions in inpatient and outpatient settings. Each block builds on the previous, adding responsibilities as fellows progress in their knowledge and skills.

Acute Withdrawal Management: (One, 4-Week Block) at Community Addiction Stabilization Center

Fellows receive intensive training in acute withdrawal management, including history-taking, assessment, and medication stabilization for multiple substance use disorders. This rotation emphasizes interdisciplinary teamwork and individualized care planning.

Ambulatory Addiction Medicine (2-Weeks/OP)

Experience outpatient addiction treatment, including non-methadone stabilization, withdrawal management, and maintenance therapies. Fellows also observe IOP and PHP behavioral therapies and gain insight into practice management.

Hepatitis-C: (Hep-C Clinic 2-Weeks@RMH)

Fellows work with a Pharmacy Preceptor to learn screening, diagnosis, and treatment for one of the most common bloodborne infections linked to substance use disorders.

Emergency Department Substance Use Disorder Treatment: (One, 4-Week Block)

Exposure to patients with substance use disorders in the ED, focusing on acute stabilization, withdrawal management, and linkage to ongoing care upon discharge.

Opioid Treatment at CompDrug (One, 4-Week Block)

Fellows gain comprehensive experience in multidisciplinary care for opioid use disorder, with a strong emphasis on methadone treatment. This rotation strengthens understanding of opioid treatment program (OTP) operations while showcasing professionalism, pharmacotherapy expertise, and cultural sensitivity. Fellows also collaborate with program alumni for a unique learning experience from a Medical Director's perspective, gaining valuable leadership and program management insights.

Outpatient Pain Management (2-Weeks)

Fellows manage chronic pain in outpatient settings using multimodal approaches, including pharmacologic and non-pharmacologic treatments.

Palliative Care (2-Weeks)

The palliative care rotation provides exposure to patients with co-occurring pain and addiction, emphasizing safe prescribing and patient-centered care.

Special Population (One, 4-Week Block)

This training includes care for pediatric patients impacted by substance use disorder, gender-specific treatment for women (including pregnancy and postpartum), and adolescents with co-occurring conditions.

Trauma-Screening, Brief Intervention, & Referral to Treatment/SBIRT (One, 4-Week Block)

Fellows participate in trauma rounds at our Level 1 Trauma Center, conducting addiction consultations and implementing SBIRT strategies to reduce future injury risk.

Inpatient and Outpatient Psychiatry (IP 2-Weeks@RMH/OP 2-Weeks@GMC)

Fellows gain supervised experience diagnosing and treating psychiatric patients with co-occurring substance use disorders, managing acute behavioral disturbances, and creating individualized treatment plans.

Longitudinal Learning Experiences:

Federally Qualified Health Centers (FQHC): Ongoing engagement with local FQHCs to understand community needs and support care for patients with substance use disorders.

Addiction Medicine Outpatient Clinic: Continuity of care with a dedicated patient panel addressing both addiction and primary care needs.
